

National Health Service Corps Substance Use Disorder Workforce Loan Repayment Program

Program Description	The National Health Service Corps Substance Use Disorder Workforce Loan Repayment Program (NHSC SUD Workforce LRP) expands access to evidence-based substance use disorder treatment in underserved, high-need communities across the country. The NHSC SUD Workforce LRP offers health care clinicians the opportunity to have their qualifying student loans repaid in exchange for serving at an NHSC-approved SUD treatment facility.

	Three years of full-time serviceUp to \$75,000(minimum 40 hours/week, 45 weeks/year)Up to \$75,000

Maternity Care Target Areas (MCTAs)	To support HRSA-designated <u>Maternity Care Target Areas</u> (MCTAs) where there is a significant shortage of maternity care providers, the NHSC will review and approve applications from maternity care health professionals by descending <u>Health Professional Shortage Area</u> (HPSA) or MCTA score, whichever is higher, and based on the funding priorities. Scores can be found on the selected NHSC-approved SUD treatment facility's <u>Health Workforce Connector</u> (HWC) profile.
	 Maternity care health professionals include: Physicians (MD/DO) Obstetrics/Gynecology Family medicine physicians (MD/DO) who practice obstetrics on a regular basis Certified nurse midwives (CNM)
	Maternity care professionals serving exclusively in a mental HPSA are not eligible to apply to the NHSC SUD Workforce LRP.

Application Requirements	Applicants must be a U.S. citizen (U.Sborn or naturalized) or a U.S. national.

Funding Priorities	 The NHSC SUD Workforce LRP gives first priority funding to: Current (or former) NHSC participants with remaining eligible loans who are seeking to extend their service obligation. Applicants likely to remain practicing in a HPSA, such as: Applicants who have completed a HRSA-funded Primary Care Training and Enhancement Training (PCTE): Primary Care Champions Program, the Addiction Medicine Fellowship (AMF), the HRSA-funded Teaching Health Center Graduate Medical Education (THCGME) Program, the HRSA-funded Advanced Nursing Education Nurse Practitioner Residency (ANE-NPR) Program or the ANE-NPR Integration Program (ANE-NPRIP). Applicants with a disadvantaged background. The NHSC SUD Workforce LRP applicants include: All SUD professionals with SUD licensure/certification or specialized training to provide SUD treatment; and Who are currently employed at a SAMHSA-certified opioid treatment program (OTP) or office-based opioid treatment (OBOT) facility.
Where Members Serve	 NHSC SUD Workforce LRP applicants must work at an NHSC-approved SUD treatment facility located in a HPSA. An NHSC-approved SUD treatment facility must meet the requirements in the <u>NHSC Site</u> Agreement and <u>NHSC Site Reference Guide</u>. Eligible NHSC-approved SUD treatment facilities can include: SAMHSA-certified outpatient treatment programs (OTPs) Office-based opioid treatment facilities (OBOTs) Non-opioid substance use disorder treatment facilities (SUD treatment facilities) Federally Qualified Health Care Centers (FQHCs) FQHC Look-Alikes Rural Health Clinics (RHCs) Indian Health Service, Tribal, and Urban Indian Health Clinics (ITUs); and some Indian Health Service (IHS) hospitals with an affiliated outpatient clinic State or federal correctional facilities Critical Access Hospitals (CAHs) Community Health Centers (CHCs) with an affiliated outpatient clinic State or local health departments or health clinics Community outpatient facilities Private practices (solo/group) School-based clinics Clinicians may qualify: Even if they work at an NHSC-approved SUD treatment facility with a HPSA score that would ordinarily be too low to qualify for NHSC funding. Using either the mental health or primary care HPSA score of their NHSC-approved SUD treatment facility.
