PHYSICIAN POSITION SUMMARY

Plans and carries out medical care practice for patients of all ages – birth through geriatric patients to assure appropriate care and treatment received as indicated by patient's age, diagnosis and psychosocial abilities. The individual in the job provides direct care for all ages.

PRIMARY TASKS & DUTIES

1. Elicits and records information about patient's medical history.
2. Examines patient to determine general physical condition or presence of disease or injury.
3. Determines nature and extent of disease or injury.
4. Prescribes and administers medications and immunizations.
5. Establishes preventive health practices.
6. Performs variety of medical duties.
7. Oversees midlevel providers to assure appropriate evaluation, treatment and outcomes are achieved.

POSITION REQUIREMENTS

Education

- Graduation from an accredited School of Medicine program.
- Licensure in Tennessee as a Medical Doctor

Experience

- Demonstrated success in working in a primary care setting preferably with at least two years' experience. .
- Demonstrated success in managing difficult patient/family situations.

Physical/ Environmental

- Occasional lifting of 20 – 40 lbs. and pushing of 5-20 lbs.
- Sitting, standing and walking approximately 80% of the time
- A medium to high level of manual dexterity required
- Bending and reaching approximately 20% of the time
- Normal accessibility and mobility throughout the region required
- Normal overtime/extended work hours
- The noise level in the work environment is usually moderate.
