

Two-Year – Loan Repayment Program


Increased Award for Primary Care Providers



UP TO
\$75,000
FOR 2 YEARS OF SERVICE

Primary care providers, including physicians, nurse practitioners, certified nurse midwives, and physician assistants (serving in a primary care HPSA* or a MCTA**) are eligible for up to a \$25,000 increase in award funding!

Higher HPSA Score = Higher Need



*With **continued service**, providers may be able to pay off all their student loans.*

Applicants working at NHSC-approved sites with higher HPSA or MCTA scores are given priority.

**MCTA – Maternal Care Target Area

Two-year Award for All Eligible Applicants





FOR 2 YEARS OF SERVICE

Offers eligible fully licensed dental and behavioral health **clinicians** loan repayment in exchange for service in an area of greatest need, called a Health Professional Shortage Area (HPSA).

Higher HPSA Score = Higher Need

Applicants working at NHSC-approved sites with higher HPSA scores are given priority.

Rural Community Loan Repayment Program



Expands and improves access to quality opioid and substance use disorder treatment in rural areas

FOR 3-YEAR SERVICE
COMMITMENT**

- Must be trained and licensed to provide SUD treatment at NHSC-approved rural SUD treatment facilities

Support & Resources – Approved Sites

NHSC-Approved Sites

- NHSC clinicians serve at approved sites throughout the nation.
- NHSC-approved sites are outpatient facilities providing primary care medical, dental, and/or mental and behavioral health services.
- The facility may be located in a rural, urban or tribal community.
- To apply to become an NHSC site, the facility must be an [eligible site type](#) and meet applicable requirements.
- The application for sites to become NHSC approved opens in late spring. Eligible sites are strongly encouraged to apply.
